



HYDROMANIA REGULATION

ADMINISTRATIVE AUTHORIZATIONS FOR WATER PARK ACTIVITIES

Authorizations and Licenses:

1. Building Permit: Building permit no. 276/C dates back to 1990 and is required for the construction and operation of the park.
2. Authorization for water attractions: Issued by Roma Capitale Municipio XII in 2018, covering the 10 water slide attractions, under the regulations of art. 69 of the T.U.L.P.S. (Consolidated Law on Public Safety).
3. Fire Prevention SCIA: Document valid for the Water Park activity, certifying that the park complies with fire prevention regulations.
4. Acoustic and Environmental Opinion: Valid to ensure that the park complies with acoustic and environmental regulations.

Seasonal Authorizations:

1. Certificate of Suitability for Use: Issued by the Provincial Technical Commission for the Supervision of Public Entertainment Venues, it guarantees that the park's activities are safe and comply with the regulations for suitability for use.
2. Temporary Authorization: Issued by the Department of Cultural Activities of Rome Capital for the seasonal activities of the park. Pursuant to Articles 68 and 80 of the TULPS.
3. Health and Hygiene Certificate: Issued by USL Roma 2 for swimming pools and compensation tanks, in accordance with public health and safety regulations.

Safety Regulations for Water Slides:

- EN 1069-1/2 (2017) Standards: These standards concern safety requirements and test methods for water slides.
- UNI 10637 (2016): Defines the standards for the management of the aquatic part and related hydraulic systems.
- Ministerial Decree of May 18, 2017: Contains safety standards for water slides in accordance with the European directive.
- Identification Codes for Attractions: Slides are regulated with identification codes for the type of attraction, as required by Ministerial Decree of May 18, 2007.

This documentation serves to ensure that the park complies with safety, hygiene, and fire prevention regulations, creating a safe and compliant environment for visitors.

I. GENERAL RULES AND CONDITIONS

The Management reserves the right to make changes and/or updates to the Rules and any changes made may be viewed on the Water Park website www.hydromania.it

Art.1. By purchasing an admission ticket (ticket, print@home), the customer accepts the following rules and authorizes A.R.IM.SRL to process his/her personal data pursuant to articles 13 and 14 of the GDPR. Complete privacy information can be found on the website at

indemnifying the Company against any type of liability.

Art.2. The Management reserves the right to request the presentation of a valid identification document upon entry. Should the visitor refuse, fail to present such documentation, or provide an invalid document, the Management reserves the right to deny access to the park. In such cases, no refund, compensation, or indemnity of any kind shall be owed, on any grounds whatsoever.

Art.3. The Park's personnel are authorised to intervene at any time in order to ensure full compliance with these Regulations. Patrons are required to strictly comply with all instructions issued by the aforementioned personnel.

Art.4. Video surveillance systems are active inside the Park for the sole purpose of supervising the safety and protection of the patrons; the images will be viewed

exclusively by Park security personnel, judicial or police authorities; complete privacy information is available on the website at

Art.5. Inside the Park, each visitor should behave in a in pursuance of public decorum and respects the rules of civil coexistence with other patrons.

Art.6. Any patron who violates these Regulations shall be held liable for any damage caused to the Park, its attractions, and property, and/or to Park personnel and/or other patrons.

Art.7. Hydromania Water Park shall not be held liable for any accidents and/or damage to persons or property resulting from the recklessness, negligence and/or lack of skill of visitors and/or from failure to comply with the "Hydromania Water Park Rules" and/or the rules governing the use of individual water and non-water attractions.

Art.8. By requesting access to the Park and/or purchasing an admission ticket, the visitor unconditionally agrees to undergo security checks on their person, clothing, backpacks, containers, bags, or any other items in their possession, in accordance with applicable laws and the provisions of this Regulation. The Management reserves the right to deny entry to any

visitors who do not consent to the checks.

Art.9. Patrons, along with their clothing, bags, backpacks, and any other containers, may be subjected to security checks both at the entrance, prior to accessing the Park, and within the Park premises. For the purposes of this Regulation, a security check is defined as an inspection carried out solely to ascertain the possible presence of objects that could potentially cause harm to others or damage to property.

Art.10. In accordance with Article 187 of the Regulation for the Implementation of the Consolidated Public Security Act (T.U.L.P.S.), the Management reserves the right to deny entry in the presence of a legitimate reason preventing access. Furthermore, the Management reserves the right to carry out a selection of visitors at the entrance for legitimate reasons related to the internal management and organization of the Park.

Art.11. The Management reserves the right to deny entry to large groups of individuals whenever deemed necessary for organisational or safety reasons, in order to ensure the proper operation of attractions and the maintenance of public order. The Management also reserves the right to remove from the Park, without any ticket refund, any patron who:

- Damages the structures, facilities, or furnishings of the Park.
- behaves in a disruptive, threatening, violent, or offensive manner towards other patrons or Park personnel

- Violates the laws or the Park's rules and regulations, as well as the specific attraction rules.
- Is found without a valid admission ticket.

In the above cases, the Management reserves the right to immediately request the intervention of the Public Security Authorities and to file a complaint with the competent authorities.

Art.12. Patrons under the age of 14 and persons with disabilities may access the Park only if accompanied by an adult. They must remain under the continuous supervision and responsibility of a legal adult for the entire duration of their stay.

The Park is staffed with lifeguards and security personnel to help ensure the safety of all patrons. However, their presence does not in any way replace the constant supervision required of the accompanying adult

Art.13. Minor patrons between the ages of 14 and 17 may access the Park unaccompanied, subject to prior assessment by a parent or legal guardian, who shall assume full responsibility for both the minor's admission and conduct throughout their stay within the Park.

Art.14. *It is prohibited to bring into the Water Park any illegal and/or harmful substances, glass containers, ceramic and/or porcelain items of any kind, beach umbrellas, lounge chairs, tables, chairs, stoves, dangerous objects (especially any offensive or defensive weapon, regardless of its category or*

use), and any item considered by the Management as inappropriate and/or dangerous.

Art.15. Access to the Water Park is prohibited for animals; only guide dogs for visually impaired individuals are allowed, except in the pool areas and the shallow water zones.

Art.16. The water park's internal parking area is free of charge and unattended. The Management declines all responsibility for theft or damage to vehicles (including cars, motorcycles, bicycles, scooters, etc.) or to any belongings left inside them. Vehicles may be parked only in accordance with the organisational guidelines provided by the authorised staff.

Art.17. The Management shall not be held liable for the theft of any items or personal belongings left unattended or stored in the lockers, including but not limited to money, jewellery, watches, mobile phones, documents, electronic devices of any kind, clothing, bags, etc. Patrons must strictly adhere to the following rules for locker use:

LOCKER USE INSTRUCTIONS

- Press the green button to rent a locker.
- Make payment either in cash (€5 in €0.50, €1.00, or €2.00 coins) or by bank card.
- Select an available locker (indicated in green) and remember its number for reopening.
- Choose a secure 6-digit PIN, required to reopen the locker. (Do not use obvious codes such as 123456.) Select

a code that is both secure and easy to remember.

- Ensure that no one is watching while entering your PIN.
- Once the PIN is confirmed, the locker will automatically open, allowing you to store your personal belongings.
- If the locker lacks sufficient space, rent an additional one.
- Do not place items in the locker until the rental process is complete.
- After each use, check that the locker door is properly closed.

LOCKER USE CONDITIONS

- Locker rental is valid for one day.
- Rentals are recorded digitally via cloud, and no physical receipt is issued.
- The locker may be opened and closed up to 30 times per day.
- After 10 incorrect PIN entries, the locker will automatically lock.
- The area is under CCTV surveillance.
- Lockers must be completely emptied at the end of the rental period.
- It is not possible to change the locker number or the reopening PIN.
- Rental fees are non-refundable.
- In case of issues, please contact the Info Point.
- Patrons who forget their PIN or locker number must wait until the Park closes to retrieve their belongings.
- Maintain a minimum distance of 2 metres from other users when operating the control unit.
- It is strictly forbidden to tamper with the control units, steal PIN codes, or force locker locks. Offenders will be reported to the competent authorities.

- *A limited number of larger lockers are available exclusively for luggage storage at a daily rate of €10. These can be rented by contacting the Info Point.*

The Management shall not be held responsible for any personal belongings stored inside the lockers.

Art.18. *In the event of adverse weather conditions, power outages, and/or any other unforeseen circumstances and/or force majeure events, the Management reserves the right to suspend or cease the operation of all attractions and to proceed with the immediate closure of the park, ensuring the orderly exit of all patrons.*

Art.19. *It is strictly prohibited to bring bicycles, scooters, skateboards, or any type of vehicle, including electrically powered ones, into the Park.*

Art.20. *Smoking is strictly prohibited in attraction access and queuing areas, on the attractions themselves, and in all areas where expressly forbidden, such as: the ticket office and entrance area, restrooms, food service areas, and the first aid station.*

Art.21. *To temporarily exit the Park, patrons must request a stamp on their skin as proof of temporary departure. Patrons who leave the Park without obtaining the stamp will not be entitled to re-entry.*

Art.22. *It is strictly prohibited to record videos or take photographs during entertainment activities, group dances, or of Park personnel.*

Art.23. *It is strictly prohibited to bring sunbeds, deckchairs, or any other furnishings onto the lawns.*

Art.24. *Climbing over any type of fence or barrier is strictly prohibited.*

Art.25. *Access to areas and/or sections of the Park that are off-limits to the public and/or reserved exclusively for Park personnel or designated for specific organised events is strictly forbidden.*

Art.26. *Any unattended items found within the Park must be handed over to Park Management.*

Art.27. *The Management shall not be held responsible for the loss and/or theft of any items left unattended within the Park.*

Art.28. *Certain areas of the Park and/or attractions may be subject to delayed opening.*

Art.29. *Any injuries occurring within the Water Park must be promptly reported to the qualified personnel located at the Park's medical station. The medical staff will provide initial first aid free of charge and assess the severity of the injury.*

A formal report will be drawn up at the medical station, including the statements of the injured party and any available witnesses. This report must be signed by the injured party. False statements shall be subject to criminal prosecution.

Art.30. *Hydromania Park is a green oasis; patrons are therefore kindly requested to respect nature and to use the designated waste disposal facilities.*

Art.31. *The hot shower service will be discontinued 15 minutes prior to the Park's closing time.*

Art.32. *The use of soap and/or shampoo is strictly prohibited in the showers located by the poolside, including those in the equipped areas of the waterslides.*

Art.33. *Stepping on flowerbeds is strictly prohibited.*

II. ADMISSION TICKETS, SUNBEDS AND UMBRELLAS

Art.34. Admission tickets are non-refundable and non-modifiable under any circumstances, except in the event that the Park is unable to open due to unforeseen circumstances. In such cases, patrons who have purchased tickets in advance will be entitled to receive a replacement ticket valid for a future date. Please contact the ticket office for further information. In the event of extraordinary circumstances requiring the suspension of all park services and attractions, no full or partial refunds will be issued by the Management.

Art.35. Before purchasing a ticket, patrons are required to inform themselves about any issues related to crowd levels and weather or climatic conditions that may limit or prevent the use of one or more attractions, as well as the overall enjoyment of the Park and/or its related services.

Art.36. Admission tickets are valid exclusively on the specific date or within the period indicated and may not be modified under any circumstances. Access to the Park is permitted only on the day or

during the period stated on the ticket. Pursuant to Article 59 of Legislative Decree No. 21 of 21 February 2014, the right of withdrawal does not apply to contracts for the provision of accommodation, transport, catering, or leisure services where the contract provides for performance on a specific date or within a specified period. The ticket is a legally recognised proof of access and, as such, includes VAT.

Art.37. The admission ticket entitles patrons to use all water and non-water attractions within the Park at no additional cost, subject to any specific restrictions that may apply under the individual attraction regulations. This does not include the rental of lockers, hairdryers, and hot showers, which are subject to separate charges.

Art.38. The admission ticket must be retained for the entire duration of the stay within the Park and must be presented upon request by Park personnel. Anyone found without a valid admission ticket will be required to leave the Park or regularise their position by purchasing a full-price ticket.

Art.39. Due to maintenance requirements, certain attractions may be unavailable. Likewise, in the event of adverse weather conditions, some attractions may be suspended for safety reasons. In both cases, no ticket refunds—either full or partial—will be issued.

Art.40. The unauthorised sale or distribution of admission tickets and discount vouchers for entry to the Park is strictly prohibited in the private parking areas or in front of the Hydromania ticket offices

Art.41. Admission tickets are divided into two categories:

⌘ **Standard Ticket (Lawn Area):**

This ticket grants access to the Park but does not include the use of sunbeds and does not guarantee the availability of umbrellas. Umbrellas are provided free of charge, subject to availability. Only umbrellas without sunbeds are available under this option, and one umbrella may be used for every five patrons.

⌘ **Relax Ticket and Gold Ticket:**

These tickets grant access to the Park as well as the use of sunbeds and umbrellas in designated areas. Holders of these tickets may only use the numbered station assigned on their ticket. Each station may include: 1 umbrella and 2 sunbeds, or 1 umbrella and 3 sunbeds, with a maximum of 5 people per station. When purchasing Relax or Gold tickets—whether online or at the ticket office—it is the customer's responsibility to select the most suitable station using the courtesy monitor or the map available online. Once purchased, the selected

station cannot be changed. If the chosen station is not satisfactory, a new ticket must be purchased to access a different station. Alternatively, patrons may move to the Lawn Area (without sunbed), but no refund—full or partial—will be granted. If a Standard Ticket has already been purchased, it is possible to purchase an upgrade allowing access to numbered umbrellas and sunbeds. This upgrade can be purchased by contacting the dedicated staff in each area or at the Park's ticket office, at the price indicated under the "UPGRADE" section of the price list.

Art.42. Sunbed and umbrella stations may not be moved. In cases where a station includes a third sunbed, it must remain in the exact position in which it was placed by Park personnel. Staff members may, if necessary, request a change in the positioning of the furnishings for safety or organisational reasons.

Art.43. It is strictly forbidden to occupy sunbed and umbrella stations without having purchased the corresponding access ticket, or to occupy more stations—or different ones—than those indicated on the valid, date-stamped ticket in one's possession.

The Management reserves the right to remove any items placed on a station (sunbed and umbrella) without the appropriate access ticket. Patrons may recover their removed belongings by making a request to Park personnel.

Art.44. Persons over the age of 75 are entitled to a discount on the price of the "Lawn Area" (Prato) ticket.

Art.45. Persons with a certified 100% disability are entitled to a discount on the price of the "Lawn Area" (Prato) ticket.

Art.46. Children up to 1.00 meter in height (including shoes or sandals) are entitled to free admission under the "Lawn Area" (Prato) ticket.

Art.47. Children under the age of 12 (if verified) and measuring less than 1.50 meters in

height are entitled to a reduced-price "Lawn Area" (Prato) admission ticket

Art.48. Umbrellas placed on the lawns, without sunbeds or other furnishings, are available free of charge while supplies last.

Art.49. On windy days, umbrellas must be closed to ensure the safety of all patrons. If Park personnel request the closure of umbrellas, it must be carried out promptly for safety reasons.

III. POOLS AND ATTRACTIONS

Art.50. Patrons are required to strictly follow the instructions provided by Park personnel and lifeguards, as well as the usage regulations specific to each attraction, and to comply with all signage displayed within the Park.

Art.51. It is mandatory to strictly observe the usage regulations displayed at each attraction and at the starting points of slides and waterslides, in order to ensure their proper use and to safeguard the safety of all users.

Art.52. For hygiene reasons and in the interest of all patrons, access to the pools and attractions must take place exclusively through the designated foot rinse stations and showers.

Art.53. The Management reserves the right to limit or deny, at any time, individual patrons' access to any attraction in the event of inappropriate behaviour,

failure to comply with the attraction's usage regulations, or conduct deemed dangerous to themselves or to other patrons.

Art.54. All slides will be closed from 1:00 p.m. to 2:00 p.m. to allow Park personnel to take their lunch break.

Art.55. All slides, pools, and both water and non-water attractions will close at least 30 minutes prior to the Park's official closing time.

Art.56. Access to attractions may be suspended earlier than their scheduled closing time (both for the lunch break and for the end of the day) in order to allow for the complete and orderly clearance of queues.

Art.57. The following clothing requirements must be observed. No refunds or discounts will be granted to patrons

who are unable to use pools, slides, or attractions due to inappropriate swimwear.

Access to the pool area is permitted only when wearing swimsuits, shorts, or T-shirts made exclusively of microfiber or polyester. Use of slides and attractions is permitted only with proper swimwear; all other clothing is strictly prohibited.

In addition, the following items are not allowed: necklaces, watches, glasses, bracelets, hair clips, piercings, earrings, diving masks, swim goggles, and pool shoes.

Any patron who, after being warned by Park personnel, continues to violate these rules will be removed from the Park without the right to a ticket refund.

Art.58. Diving into the pools is strictly prohibited.

Art.59. Wearing glass diving masks, sunglasses, or prescription glasses—whether made of glass or plastic—is prohibited in the pools.

In the case of plastic materials, the Management reserves the right to grant exceptions.

Art.60. Entering the pools or using the slides while under the influence of alcohol, medication, drugs, or any other substance that impairs physical or mental condition is strictly prohibited

Art.61. Access to pools and attractions is prohibited for individuals with wounds, abrasions, lesions, or skin conditions

resulting from infectious diseases (e.g., warts, dermatitis, fungal infections, etc.). Pool access will be denied by surveillance personnel. Patrons presenting such symptoms may access the pools and attractions only upon presentation of a medical certificate confirming that the condition is compatible with bathing in public facilities.

Art.62. The use of the Park's waterslides is prohibited for individuals with heart conditions, pregnant women, persons suffering from epilepsy or claustrophobia, and in general for anyone with health issues that could be aggravated by this type of activity. Use is also prohibited for persons with disabilities, individuals with impairments, and those who are not self-sufficient, unless otherwise assessed and authorised by Park Management.

Art.63. It is prohibited to use the slides and waterslides while wearing T-shirts, tank tops, or any clothing other than swimwear.

Furthermore, during use of the slides and waterslides, it is forbidden to wear necklaces, watches, glasses, bracelets, hair clips, piercings, earrings, diving masks, swim goggles, or pool shoes, unless otherwise authorised by Park Management.

Art.64. Wearing a swim cap is not mandatory.

Art.65. Before accessing any attraction, patrons must remove prescription glasses and any accessories (such as necklaces, watches, piercings, hair clips, bracelets, rings, jewellery, mobile phones, cameras, etc.). Park personnel are not permitted to hold or safeguard patrons' personal belongings.

Should this instruction not be respected by staff, the Management shall not be held liable for any loss or damage to such items.

Art.66. For safety reasons, selfie sticks and similar devices used to support cameras, mobile phones, or other technological equipment are not permitted on any attraction.

Art.67. It is prohibited to slide down the waterslides simultaneously with another person, as well as to push or collide with another person at the start of the waterslide.

Art.68. It is prohibited to walk around or remain in the pools or adjacent areas without wearing a swimsuit, or while wearing only underwear. Swimsuits worn to access the pools must be appropriate and respectful of public decency. Underwear of any material other than microfiber or polyester may not be worn beneath or in place of a swimsuit. In the above-mentioned areas, behaviour must also reflect respect for public decency and hygiene.

Art.69. For safety reasons, certain attraction slides may be subject to specific restrictions in order to ensure the protection of users.

Art.70. For attractions with height and/or weight restrictions, patrons are required to undergo height measurement and/or weighing when requested in accordance with the Park's or the attraction's safety regulations. Measurements are carried out discreetly and with full respect for patrons' privacy. Patrons who refuse to undergo the required measurement or weighing will not be permitted to access the attraction and will not be entitled to any claim or refund for the ticket purchased. If unsure about their own height or weight, patrons may request to be measured or weighed before entering the queue for the attraction. Staff assigned to perform these checks are trained to ensure a fast, safe, and respectful experience, while minimising any potential discomfort for patrons.

Art.71. Wearing shoes is prohibited in areas designated as shoreline zones.

Art.72. It is strictly prohibited to skip queues formed by waiting patrons or to reserve a place in line for others. Patrons who violate this rule may be removed from the Park. Leaving a queue and returning to the same position later is not permitted under any circumstances.

Art.73. Patrons are required to immediately exit the pools at the approach of a thunderstorm.

Art.74. Running is prohibited, especially around the poolside areas.

Art.75. Pushing or colliding with other individuals in the pools is strictly prohibited.

Art.76. Playing with balls or paddles is prohibited in the pools and in shoreline areas.

Art.77. Climbing on artificial rocks is strictly prohibited.

Art.78. Spitting into the pool water, releasing any type of liquid, urinating, defecating, or cleansing wounds in the pools is strictly prohibited. It is also forbidden to enter the water if any part of the body is covered with oils, creams, or similar substances of any kind.

Art.79. Diapers are not permitted in pools and attractions, except for swim diapers specifically designed for water use.

Art.80. Picnicking is prohibited in areas designated for waterslide facilities.

Art.81. Participants in birthday parties organised by Hydromania, identified by a dedicated wristband, are entitled to use the "skip-the-line" service. This service allows them to bypass regular queues for access to attractions.

Art.82. The use of armbands is not permitted on the waterslides named *twister* and *K2*

Art.83. By participating in the Foam Party, the patron expressly accepts that entering the water while still covered in foam is not permitted, in compliance with hygiene and safety regulations. At the end of the event, the foam must be removed by rinsing with running water.

To this end, a designated operator will carry out the foam removal using specific rinsing stations. The patron accepts this procedure as a mandatory condition for access to the water areas. Control staff reserve the right to deny pool access to anyone who does not undergo the foam removal procedure..

Art.84. Opening the mouth during the foam machine spray is prohibited, in order to prevent irritation of the respiratory system.

ANNEX SWIMMING POOLS AND ATTRACTIONS

Considering the above articles relating to access and use of attractions, further specific rules and restrictions for each attraction are provided below in summary form.

- ⇒ Before accessing the attraction, it is mandatory to consult the information sign regarding health restrictions. In case of doubt, it is recommended to consult the staff.
- ⇒ Management recommends maintaining the correct position assumed at the start of the slide until the end of the landing.
- ⇒ It is mandatory to strictly follow the instructions provided by the lifeguards and the information signs regarding the position to be assumed during the descent.
- ⇒ It is mandatory to comply with the rules and height and weight restrictions of the attractions.
- ⇒ It is mandatory to queue in an orderly manner and wait for the lifeguards to give the go-ahead.
- ⇒ It is mandatory to leave the landing area immediately to avoid obstruction.
- ⇒ If necessary, after collecting the float, you must immediately return to the queue at the start of the attraction without stopping, to allow all users to use the attraction correctly.
